VTA Board of Directors:

VTA's BART Silicon Valley External Affairs Team (EAT) worked closely with staff from both the City of San José and the City of Santa Clara to execute master agreements in late 2020. Currently the EAT is working on subsequent cooperative agreements to address specific details of City engagement during key Project milestones. The first cooperative agreement will be brought to San Jose City Council June 8, 2021. An attachment to the cooperative agreement is VTA's BART Silicon Valley Phase II Extension Project (Phase II Project) Construction Outreach Management Program (COMP).

Developing and implementing a COMP is a requirement identified in the Final Supplemental Environmental Impact Study/Final Supplemental Environmental Impact Report for the Phase II Project. The COMP will be included in all four contract packagesand is comprised of three separate plans: the the Construction Education and Outreach Plan (CEOP), Construction Transportation Management Plan, and the Emergency Services Coordination Plan. The COMP Relationship Diagram, attached to this email, outlines the process by which the COMP is being developed, the relationship(s) between various plans and programs, and identifies responsible and engaged parties for each element.

Since April of 2018, VTA has worked collaboratively conducting workshops and meetings with staff from both the Cities of San José and Santa Clara, neighborhood and business associations, the three Phase II Project Community Working Groups, the general public, and local public safety providers.


