


- Reviewing reimbursement requests.
- Allocation through FY24: \$323.3M
- Expenditure through May 2024: \$210.3M



HIGHWAY INTERCHANGES

- Calaveras Near-Term Improvements: Construction contract to be awarded in July.
- Allocation through FY24: \$436.2M
- Expenditure through May 2024: \$153.1M



BART PHASE II

- Tunnel and Track Progressive Design Build Contract (CP2) design activities, Tunnel Boring Machine (TBM) procurement, BART railcar procurement, real estate acquisition, utility relocations, design of other construction packages, and program management.
- Allocation through FY24: \$725M
- Expenditure through May 2024: \$278.9M



BICYCLE & PEDESTRIAN

- Capital Projects: Executed funding agreements for the following projects -
 - Mountain View's Stevens Creek Trail Ext to W. Remington Dr to MVHS
 - San Jose's Coyote Creek Trail Completion

- Allocation through FY24: \$66.6M
- Expenditure through May 2024: \$11.6M

- Expenditure through May 2024: \$4.7M




COUNTY EXPRESSWAYS

- Expenditure through May 2024: \$28.7M




SR 85 CORRIDOR
