
DISCUSSION:

April 2024 total monthly system ridership was 2,368,877, an increase of 16.7% over April 2023. The total monthly bus ridership was 1,965,191, an increase of 17.1% over April 2023. The total monthly light rail ridership in April 2024 was 403,686, a 14.6% increase over April 2023. April 2024 monthly system ridership increased by nearly 1.0% compared to March 2024. April 2024 system ridership (bus and light rail) is at about 79% of pre-pandemic ridership.
